- Permit approval is based upon compliance with state and local health ordinances.
- Please visit the Records Division of the Big Spring Police Department, located at 3613 W. Hwy 80, or call at (432) 264-2567 to determine if a **Roadway Food Vendor/Fixed Location Food Vendor** permit is required.
- Food Service Permits shall be renewed every two years.
